TERMS OF USE

These Terms of Use (the "Preprint Terms") apply to your use of the webpages and online services of Therapoid, LLC ("we", "us" "our" or "Therapoid") relating to Therapoid Preprint Service site located at <https://therapoid.net/en/preprint> and also known as "Knowledge Uploads", "Knowledge Center", Preprint Server and Knowledge Center", "Preprint Server and Knowledge Uploads", and "Preprint Server, and/or "Preprints" (this site, with any related pages, subpages, subdomains, and successor sites, the "Preprint(s)").

Please read these Preprint Terms (collectively with the following policies and terms, which are incorporated herein by reference, Therapoid LLC's [Privacy Policy](#), [Terms of Service](#), [Digital Millennium Copyright Act Policy](#) and the [Therapoid User and Leader Handbook](#), the "Preprint Terms of Use") fully and carefully before using the Preprint Server and any related services, features, content platform or applications offered by Therapoid (the Preprint Server and such related services, features, content, platform or applications, the "Preprint Services"). Let us know if you have any questions. The Preprint Terms of Use set forth the legally binding terms and conditions for your use of the Preprint Services, whether you are a submitting author, a User (defined below), or merely a visitor who is browsing the Preprint Server or Preprint Services or Articles (defined below). 1. Definitions.

- 1.1. "Articles" means scientific or research articles and manuscripts and accompanying scholarly materials and research.
- 1.2. "Content" means materials and content included, accessible, displayed or performed on the Preprint Services, including, but not limited to text, graphics, articles, photographs, images, illustrations Articles, and User Contributions.
- 1.3. "DOI" means Digital Object Identifier.
- 1.4. "Patient Information" means confidential patient information.
- 1.5. "User" means any visitor to the Preprint Server, the Therapoid' Therapoid™ scientific collaboration website (including without limitation, with related pages, subpages, subdomains, and successor sites), who possesses an Account as defined in section 2 of the [Terms of Service](#).
- 1.6. "User Contributions" means information, including but not limited to peer reviews, comments, and feedback, which are provided or submitted by you, other Users, or visitors, in utilizing the Preprint Services.

- 2. **Description.** The Preprint Server is an online, open access publication platform for Articles. Perpetual access is necessary to maintain the scholarly record, and after an article is published on the Preprint Server, it is citable and therefore cannot be removed. Accordingly, Therapoid keeps a permanent record of every submission and replacement or update. Copyright in Articles and any such other submissions and replacements or updates remains with the author(s).
- 3. **Visitor Access.** Any visitor may access the Preprint Server and the Articles and other content published or otherwise included or accessible on the Preprint Server.
- 4. **Article Submission.** Articles may be submitted for publication on the Preprint Server in draft or final form, provided that the content is unpublished at the time of submission, and all its authors have consented to its submission for publication on the Preprint Server.
- 5. **Consent to Preprint Terms of Use.** By using or visiting the Preprint Server, you agree to the Preprint Terms of Use. In order to submit an Article for publication, you must register for an Account as defined in section 2 of the [Terms of Service](#). By submitting an Article, you: i) expressly consent to text mining of the Article (e.g., by search engines or researchers); and ii) certify that the Article is available under the [Creative Commons Attribution License \(CC BY-NC 4.0\)](#) (the "CCL").
- 6. **Discretion to Publish; Removal.** Therapoid shall determine in its sole discretion whether to publish any submitted Article and reserves the right not to publish anything that does not meet its standards. Therapoid further reserves the right to identify and remove any Articles that contain plagiarized material (see also section 21) or describe experimental work that is not performed in accordance with the relevant ethical standards for research using animals or human subjects.

7. **Condition of Articles.** Visitors should be aware that Articles on the Preprint Server have not been finalized by authors, may contain errors, and report information that may not be accepted or endorsed in any way by the scientific or medical community.
8. **Use of Preprint Server and Content.** The Preprint Server and its contents may only be used in accordance with the Preprint Terms of Use. All Content may be protected by copyright or other proprietary rights and laws. You shall abide by all copyright notices, trademark rules, information, and restrictions contained in any Content accessed through the Preprint Services. All Articles published by Therapoid on the Preprint Server, unless otherwise indicated, are licensed by the respective authors for use and distribution by you subject to citation of the original source in accordance with the CCL. All peer reviews and user comments, unless otherwise indicated, are also licensed by their respective authors for use and distribution by you subject to citation of the original source in accordance with the CCL. We will then review your complaint and decide whether there has been a failure to comply with these Terms. We will inform you of the outcome of our review within a reasonable time of receiving your complaint.

23. Entire Agreement; Miscellaneous. These Preprint Terms, including without limitation the Privacy Policy and any: (i) notices, terms and items incorporated into any of them; (ii) additional terms and conditions contained on any Therapoid associated site and pertaining to particular activities or content contemplated or addressed hereunder; and (iii) our disclosures and your consents provided on or in connection with the Preprint Server or any Therapoid associated site, or any content, service or other activity; constitute the entire agreement between you and Therapoid regarding the subject matter of the foregoing (collectively, “Entire Agreement”). Introduction

The Therapoid Preprint service is freely and openly available to life science manuscript authors of the global scientific community.

We believe the free expression of scientific thought should transcend political, socioeconomic, ethnic, and linguistic borders and barriers.

We ask the community to assist us in maintaining this open service by self-policing conduct.

Guidelines

1. Therapoid’s preprint service is designed for manuscripts before they are published within Open Access journals. The author(s) have copyright to their work, however in exchange for listing the manuscript for public scrutiny on the preprint server, the author(s) agree to a Creative Commons license attribution as listed within the Therapoid [Terms of Service](https://therapoid.net/en/legal/terms-of-service/) (TOS) located at <https://therapoid.net/en/legal/terms-of-service/> and within the [Creative Commons](https://creativecommons.org/licenses/) attribution list located at <https://creativecommons.org/licenses/>.
2. The anyone in the community can nominate a submission for a Digital Object Identifier (DOI). The submission shall then be made available for community voting whereby the majority vote will prevail. In the absence of a community vote, Therapoid’s science team will become that determining authority for the award of a DOI.

3. The manuscript shall be tagged with one of the following Creative Commons symbols in accordance with the license the author(s) choose:



- a. also known as “CC BY”. “This license lets others distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation. This is the most accommodating of licenses offered. Recommended for maximum dissemination and use of licensed materials.



- b. also known as “CC BY-SA”. “This license lets others remix, tweak, and build upon your work even for commercial purposes, if they credit you and license their new creations under the identical terms. This license is often compared to “copyleft” free and open-source software licenses. All new works based on yours will carry the same license, so any derivatives will also allow commercial use. This is the license used by Wikipedia and is recommended for materials that would benefit from incorporating content from Wikipedia and similarly licensed projects.”



- c. also known as “CC BY-ND”. “This license allows for redistribution, commercial and non-commercial, as long as it is passed along unchanged and in whole, with credit to you.”



- d. also known as “CC BY-NC”. “This license lets others remix, tweak, and build upon your work non-commercially, and although their new works must also acknowledge you and be non-commercial, they don’t have to license their derivative works on the same terms.”



- e. also known as “CC BY-NC-SA”. “This license lets others remix, tweak, and build upon your work non-commercially, as long as they credit you and license their new creations under the identical terms.”



- f. also known as “CC BY-NC-ND”. “This license is the most restrictive of our six main licenses, only allowing others to download your works

and share them with others as long as they credit you, but they can't change them in any way or use them commercially."

- g. Those author(s) who do not choose a license shall be appointed a license by the Therapoid staff. Such manuscript shall be annotated with the following license:



- i. also known as "CC BY". "This license lets others distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation. This is the most accommodating of licenses offered. Recommended for maximum dissemination and use of licensed materials."
4. Once a manuscript is published, unless it was listed within Therapoid prior to publication, it should not be listed within Therapoid.
 5. Those manuscripts that are published after listing within Therapoid should be annotated with the published location. Such annotation shall be a clearly marked manuscript with the word "PUBLISHED" across the digital rendering of the manuscript and be hyperlink to the published version within an Open Access journal.
 6. In exchange for assisting authors with gaining publications, author(s) agree to publishing those manuscripts commented upon by the scientific community (within Therapoid) to have such manuscripts only published within Open Access journals.
 7. Those manuscripts published because of listing on a preprint server, including Therapoid, should be annotated as "published" with a digital object identifier (DOI), should one not already exist, its published citation and reference location should be provided to Therapoid.
 8. By listing your manuscript before submission to peer-reviewed journals, one gains the opportunity to share knowledge long before a journal decides to accept a paper and peer-review it. This creates a competitive environment between publishers to publish your manuscripts.
 9. Before posting your manuscript to the preprint server, the author(s) should familiarize themselves with journal policies, patent implications, and grant funder policies regarding the early dissemination of manuscripts.
 10. To those manuscripts developed within Therapoid, a log of all participation, or a "pre-Peer Review", is embedded within the manuscript when it is freely listed in the preprint server. This pre-Peer Review could contain comments and annotations provided by the

scientific community. Therapoid will try in a good faith effort to host and custodian such manuscripts in the spirit of positive collaboration. Comments provided that are not in the spirit of positive collaboration and in accordance with the Therapoid [Terms of Service](https://therapoid.net/en/legal/terms-of-service/) located at <https://therapoid.net/en/legal/terms-of-service/> could be remanded for deeper review by the Therapoid staff and could result in the comment(s) being deleted and the user commenting suspended from the Therapoid platform.

11. Manuscripts listed within Therapoid are not peer reviewed. Caution should be made in referencing or citing such listed manuscripts.
12. We leave it to the scientific community to screen manuscripts for potential security risks, plagiarism, copyright violations, and
13. When a manuscript is updated or a new version is completed, it will not replace the version current at the time on the preprint server. Therefore, please do not upload many versions of the same manuscript as this would unduly burden the preprint server.
14. Authors may choose to list their contact information. Those authors who do so hold Therapoid harmless for private or publicly disclosed conversations.
15. Manuscripts should be free of unethical and illegal content. Therapoid reserves the right to make such a determination in accordance with its [TOS](#).
16. As Therapoid may gain new insights about the use of its service, we reserve the right to modify and enforce our TOS and TOU anytime.
